ARCHITECTURE COMMITTEE (ARC):

 Thank you, Joanna, and ARC committee volunteers: Stephen Hall (board), Skip Brindle (former member), Sara Gahm, Royce Stine, Dawn Tremaglio, Diane Wilfley and Michael Fleming for enforcing our beautification guidelines.

COMMUNITY MAINTENANCE:

- The Wall Task Force, board volunteers, John Stoehr and Stephen Hall have identified high priority wall repairs with expected vendor quotes arriving soon.
- The entire community irrigation piping

replacement, along with new smart controllers using the phone app, has been completed, resulting in water cost savings.

- Trees that did not survive the record hot AZ summer heat, have been and will continue to be removed. Due to our significant tree loss, Brightview has volunteered to significantly reduce the cost of purchasing and planting 49 trees for our association.
- Ajax liquid dish soap suds added repeatedly to the fountain have caused significant damage. This form of vandalism is not as funny or entertaining as it seems on the surface, but instead causes high corrosion damage to the water feature that has proven to be very expensive for the association. Please help us in discouraging this activity and be sure to call the Gilbert police (non-emergency) when this activity is in progress, 480-503-6500.

COMMUNITY IMPROVEMENTS:

- The Dream Team Task Force has collected vendor quotes and the board chose a vendor to level the deteriorating amphitheater, creating a natural stage that extends from the clubhouse glass sliders. The step near the stage will become a convenient equipment ramp. The long overdue surfacing of the walkway areas around the clubhouse will also be reresurfaced to match the new stage surface. As our duties on this task force are coming to a close, it is important to thank this super fun group of volunteers for bringing their ideas and time to make this project possible: Donna Luse (board), Marie Nowicki (board), Melitta Fleming, Diana Hummel, and Jetta Dailey.

Suds in the Fountain

Ceeing suds in the main entry fountain, south of Elliot, is not unusal. Thanks to volunteer resident Ray Myrabo, chances are you don't notice them. He takes the time to put de-sudzer into the fountain as and when needed.

While a thrill for the individual(s) throwing soap into the fountain and watching the science of the bubbles/suds occur, this "free entertainment" is not so free at all. It takes sometimes a few gallons of de-sudzer to treat suds, not to mention time to dig out the soap bottles.

With how frequently we have seen it happen this fall, it also means the cost of having to empty out murky fountain water and constantly repairing the fountain seat edge with stucco and paint.

Please assist the Association in eliminating this careless act, keeping the fountain sparkling and maintenance costs minimal. If you see the act in progress, please report it to the police.

The Lakes Don't Eat Candy

The lighted holiday boat parades are a big **L** part of The Islands tradition. Creative displays and bright, colorful lights illuminating the water... it's magical! But the magic fades the next day as candy, litter and debris are tossed and left all over the lakes and common areas. It's a mess to clean up, as well as endangers the wildlife.



How does littering affect our water? Bob Revolinski, Aquatic Biologist for Solitude Lake Management states: "When debris plastic, bottles, cigarette butts, etc. – are thrown on the ground, gets washed into storm drains and directly into our waterways. In addition to potentially choking, suffocating, or disabling aquatic life like ducks, fish, turtles, and birds, litter decreases oxygen levels in the water when it decays."

Please help to keep The Islands lakes, common areas and wildlife clean and safe this holiday season, by not throwing candy at the boat parades and taking all litter with you when you leave. Thank you!

treasurer's note by Chuck Hummel, Board of Directors Treasurer

Financial State of the Community

The Board of Directors and Finance Committee are looking forward to a leaving 2020 behind and starting a New Year filled with hope and promise for the Islands Community. There are challenges ahead but we are committed to continue our efforts to manage The Islands finances in a prudent manner and work toward enhancing and improving our community assets for all to enjoy.

Our 2021 budget was completed which necessitated a 5% increase in community assessments for the coming year due primarily to increased funding of our **Reserve Fund** as a result of our rapidly deteriorating infrastructure, primarily our community walls. You may have noticed that our approximately 10-miles of community walls are in need of major repairs and painting.

During the past several years we have been playing "catchup" with the rising costs of our aging community assets and have experienced some rather large unanticipated expenditures for infrastructure repairs and replacements. The biggest financial issue currently facing us is and has been the deterioration of our community walls.

Although we have spent over \$1,000,000 since 2017 on wall construction, repairs and painting, our projected cost over the next 5-years is estimated to exceed \$2,000,000 in order to maintain and improve the appearance of our community. This amount exceeds the total funds currently available in our Reserve Fund. As a result, it has necessitated a substantial increase in future annual funding of reserves as a portion of our community assessments. We expect this increased funding to continue for

several years which will impact future assessments as well.

On a brighter note, we are looking forward to bringing back our community events for 2021 for our mutual enjoyment and sense of community. We all have missed our ability to gather together and enjoy our Islands. We are hopeful that a vaccine will be available soon so that we can hold these events that bring our community together and allow us enjoy one another again.

With the federal and state elections concluded, we will soon be turning our attention to The Islands Board Elections. I am sure that our elections will not be as contentious as the election season that we have recently endured. In a few months we will be voting to elect one candidate for the Board. We will again have both paper ballots and electronic voting available to the community. The electronic voting option has made voting easier and has increased voter participation and community involvement in our elections. We hope that you will investigate the candidates and choose the candidate best suited to support your vision of The Islands. Every election is important so be sure to vote for your choice of Board candidates in the coming election.

We hope that you continue to enjoy our community and become more involved with us in keeping The Islands one of the best premier communities in Arizona. We encourage you to review the Islands financial statements, budgets and our investment policy on our community website and of course join us at our monthly meetings. You can also contact our FirstService management team or any of our board members if you have any questions, comments or suggestions.

compliance corner

As a reminder construction dumpster, portable storage units, portable toilets may be permitted (please refer to The Islands Architectural Guidelines #10). A homeowner may have the dumpster, temporary storage or porta potty unit for up to two weeks in any calendar year. If a homeowner needs additional time, an extension may be granted for extenuating circumstances,

but please remember to provide a prior written notice to the onsite office with the following information:

- The dates the storage unit, portable toilet or dumpster will be on your property
- Intent of use

The management staff, Board of Directors and/or Architectural Review Committee reserves the right to grant additional time as determined on a case-by-case basis. It is preferred that the dumpster/ temporary portable storage unit be placed in the driveway while ensuring that it does not block the sidewalk. If the driveway is not an option, placement on the street is allowed as long as it does not interfere with sidewalks, pedestrians, vehicular traffic or sightlines for vehicular traffic. Only one porta potty may be located in the front of the property for the purpose of supporting approved construction and should be positioned out of view of neighboring properties as much as possible. The porta-potty must be cleaned at a minimum of one time per week.

Keep in mind, having ARC approval on a project does not automatically permit the use of a dumpster/temporary storage unit or portable toilet.

Please be sure to reach out to any of the onsite staff members for guideline assistance. We're always more than happy to help.

Gilbert Bulk Trash Pickup



The Town of Gilbert bulk trash pickup is every ▲ 5 weeks. Place acceptable bulk items in the street against the curb no earlier than the Saturday prior to your collection week and no later than 5am on Monday of your collection week.

No bulk trash pickup is scheduled for December 2020. Bulk trash pickup will be on the following dates in 2021: January 4th, February 8th, March 15th, April 19th, May 24th, June 28th, August 2nd, September 6th, October 11th and November 15th.

Sub-Associations and Architectural Forms
